

## **Concept Note**

## AFPPD 2nd Meeting of the Standing Committee on Active Ageing

9:00 – 13:00 17 August 2017 | Ho Chi Minh City, Vietnam

#### **Background:**

Asian Forum of Parliamentarians on Population and Development (AFPPD) has spearheaded mainstreaming healthy and active ageing at regional and global fora since its 11th General Assembly in October 2015. Two significant milestones have been reached during the first year of AFPPD's Strategic Cycle (2016-2019). First, AFPPD co-organized the Global Conference of Parliamentarians on Population and Development (GCPPD) toward the G7 Ise-Shima Summit in April 2016. A session entitled "active ageing and well-being for ageing population" received a highest post-conference evaluation rate as relevant in all sessions by participating parliamentarians. They also integrated policy recommendations on ageing into the *GCPPD Declaration and Recommendations to the G7 Ise-Shima Leaders.* One month later at the G7 Summit, the world leaders made a specific reference of "active ageing movement" in their outcome documents, namely, the *G7 Leaders' Declaration* and the *G7 Ise-Shima Vision for Global Health.*1

Second, in September 2016, AFPPD held its inaugural meeting of the Standing Committee on Active Ageing. Asia-Pacific parliamentarians confirmed again their collective efforts to address population ageing as common agenda in proactively responding to socio-economic challenges posed by rapidly ageing societies. The meeting identified four areas of topics as common challenges and opportunities to be addressed by AFPPD: (1) need for integrated community care services for older persons, especially a system of long-term care (LTC) that meets both the needs of older persons and their family members as care providers; (2) monitoring national-level progress vis-à-vis regional and global frameworks such as the Madrid International Plan of Action on Ageing (MIPAA) and the WHO Global Strategy and Action Plan on Ageing and Health, specifically through timely data collection and analysis for ageing related policies and advocacy to change the prevailing perception of ageing through the global campaign to combat ageism; (3) universal health coverage (UHC) to address healthy and active ageing, especially enhanced primary prevention and care services including wellness programs; and (4) income security and social protection schemes particularly for most vulnerable older persons, including women and LGBT persons.

Building on these achievements and shared challenges ahead, this second Standing Committee meeting will take up **the role of community in providing integrated LTC and related support** as an overarching theme. Evidence shows that older persons wish to "age in place" or "age in communities." Lessons from aged societies like Japan also indicate that integrated community-based LTC has proven effective in meeting the needs of older persons themselves and their family members' while delivering needed services in an economically efficient manner from the government's perspective. Yet, Asia, as the most rapidly ageing region in the world, represents almost 50% of the world's health worker shortage. Moreover, a majority of AFPPD member countries are pre-ageing low-middle income societies with not sufficient preparation time for enacting age-friendly legislation and implementing such policies and programmes. These factors beg the question concerning the role

of parliamentarians in creating age-friendly societies for older persons to "age in place" with access to affordable healthcare and LTC services.

The Standing Committee meeting will approach this theme in the context of three roles of parliamentarians: (a) making evidence-based policies and legislation on ageing at the <u>national</u> level especially for community-based LTC; (b) holding governments accountable for implementing <u>regional</u> commitments, such as MIPAA's articles related to community-based long-term care <sup>2</sup>; and (c) advocating for a <u>global</u> campaign toward a legally binding international convention on ageing, focusing on the importance of setting standards of quality LTC and filling a normative gap in effective implementation of community-based integrated services assisted by care providers including family members and foreign nationals. This standard setting can encompass protecting the rights of older persons to "age in place" as well as care providers' in the time of cross-border movement of health workers, especially in Asia-Pacific.

#### **Purpose:**

The Asian Forum of Parliamentarians on Population and Development (AFPPD) will convene the second meeting of the AFPPD Standing Committee on Active Ageing on 17 August 2017 in Ho Chi Minh City, Vietnam. The main purpose of the  $2^{nd}$  Standing Committee meeting is to further strategize AFPPD's parliamentary advocacy work in mainstreaming healthy and active ageing in the national, regional and global context, thus enabling AFPPD to play an effective and impactful role as a regional network of parliamentarians.

Building on the knowledge and experiences shared between the AFPPD parliamentarians and the experts during the 2016 inaugural meeting in Hanoi, this second meeting is intended include legislators from APEC Member Economies to deliberate and confirm jointly AFPPD National Committees' and other parliamentarians' recommended collective and individual actions to ensure the dignity of every older person in the region through promoting access to health and wellbeing into older age.

## Rationale for holding the meeting along with the APEC Events:

The 1st meeting of the Standing Committee on Active Ageing has prompted AFPPD's ageing related activities to be aligned with ongoing regional and global efforts led by inter-governmental bodies. These include the MIPAA, the Asia-Pacific Economic Cooperation (APEC) Healthy Asia-Pacific 2020, and global initiatives including a movement toward a Convention on the Rights of Older Persons.

As such, the 2<sup>nd</sup> meeting of the Standing Committee on Active Ageing will be scheduled during the same week of the *Mutistakeholder Forum* on Ageing toward the APEC, under the theme of *Investing in Healthy and Active Ageing for Sustainable Growth: A Regional Approach to Promoting Innovative LTC.* This Forum will take up, among others, human resources gaps and requirements in providing LTC in the Asia-Pacific region. Economic and social imperatives of promoting community-based integrated LTC will be introduced, based on the lessons learned from aged societies including Japan.

In order to enhance their learning and enrich knowledge sharing opportunities, participating parliamentarians are encouraged to attend the *Multistakeholder Forum* prior to the Standing Committee meeting. In addition, an exhibition session of elderly-friendly innovative products and

field visits to community stakeholders and LTC facilities such as inter-generational centers will be arranged in/near Ho Chi Minh City.

## **Objectives:**

The specific objectives of the 2<sup>nd</sup> meeting of the Standing Committee on Active Ageing are as follows:

- (1) Review the implementation plan drafted by the AFPPD Secretariat and approved by the Executive Committee based on the outcomes of the 1st meeting of the Standing Committee on Active Ageing;
- (2) Share follow-up actions taken by National Committees which are represented by participating Standing Committee members, especially to learn from national case studies adopting evidence-based policymaking and program design for older persons, focusing on community-based integrated LTC;
- (3) Gain in-depth understanding on regional instruments such as the MIPAA, specifically in light of community-based integrated LTC services for older persons, and review the implementation status of the participating countries/economies;
- (4) Understand accurately on-going and growing debate on the need for an international convention on the rights of older persons, and discuss the rationale for supporting (or not) such a cause as a regional network of parliamentarians;
- (5) Revisit the AFPPD Strategic Plan (2016-2019) and reframe high priority ageing issues as common regional and global agendas, by taking into consideration the knowledge gained through the *Multistakeholder Forum*, the exhibition session, and field visits scheduled on 15-16 August 2017;
- (6) Consider and agree on AFPPD's short to medium term recommended actions to be presented to the AFPPD  $83^{rd}$  Executive Committee meeting and the  $12^{th}$  General Assembly in October 2017 [as well as to consider Asia-Pacific parliamentarians' joint recommendations to the APEC Senior Officials and the Health Working Group-TBD].

#### **Expected Outcomes:**

- A. Shared knowledge on evidence-based policymaking and program design for older persons to benefit from community-based integrated LTC, particularly focusing on human resources gaps and requirements in LTC in the AFPPD member countries [Objectives 1, 2];
- B. Deepened understanding on ageing specific regional and global commitments including the MIPAA and implementation challenges, with a special focus on community-based integrated LTC [Objective 3];
- C. Increased awareness on the need for a legally binding international convention related to the older persons, in order to address new or emerging challenges faced by ageing society and protect the rights of a growing number of older persons worldwide, by filling a 'normative gap' especially in the area of implementing community-based integrated LTC supported by family, community, and care providers with diverse backgrounds and skills [Objective 4];



D. Enhanced political will and commitment of participating parliamentarians to play an active role at the national, regional and global levels in creating age-friendly societies for both current and future generations of older persons, to ensure their wellbeing and dignity at the last stages of their lives [Objectives 5, 6].

## **Participants:**

- 1) Members of the AFPPD Standing Committee on Active Ageing
- 2) Representatives from the AFPPD member National Committees (which have not yet nominated a Standing Committee member)
- 3) Members of Parliaments from APEC Member Economies (other than AFPPD members) who will have participated in the Multistakeholder Forum
- 4) Experts from academia, international organizations, and civil society organizations

#### Format:

A participatory format will be adopted as much as possible to create opportunities for an inclusive and diverse discussion among participants and experts. In order to have a constructive discussion to generate expected outcomes, the meeting will rely on experts' inputs upfront for the three areas of topics. An open discussion follows in order to consolidate recommendations to be made to the AFPPD Executive Committee and the 12<sup>th</sup> General Assembly and the MIPAA Regional Review Meeting [and the APEC Senior Officials and Health Working Group – TBD].

The Vietnamese version of the AFPPD's *Briefing Cards for Parliamentarians (2016)* will be launched at the start of the Standing Committee meeting. This AFPPD flagship knowledge product covers 15 ageing related good practices and relevant data, which will be introduced to participants as needed at the meeting.

#### About AFPPD:

The Asian Forum of Parliamentarians on Population and Development (AFPPD) is a network of 29 national committees of parliamentarians from Asia-Pacific countries. AFPPD promotes advocacy and parliamentary actions on population and development issues at the global, regional and national levels. For the past 35 years, AFPPD has been playing a crucial role in engaging parliamentarians across the region in a wide variety of issues related to population and development. AFPPD's current model for change is aimed at educating and motivating parliamentarians to take up the challenge of bringing about legislative reforms and drive change on population and development issues outlined in the Programme of Action of the International Conference on Population and Development (ICPD PoA), the ICPD Beyond 2014, as well as the Agenda 2030 for Sustainable Development.

AFPPD is governed by the General Assembly; managed by the Executive Committee; advised by three Standing Committees on its strategic priorities, namely, active ageing, investing in youth and gender equality and women's empowerment; and supported by the Secretariat located in Bangkok, Thailand.
