Feedback Survey for Online Seminar on Ageing under the COVID-19 Pandemic

The Asian Forum of Parliamentarians on Population and Development (AFPPD)

This feedback survey was conducted following up on the online seminar held in December 16, 2020 on "Ageing under the COVID 19 Pandemic." The survey was intended to assess the usefulness of the seminar in view of AFPPD's objectives and seminar contents (in needs and timeliness) as well as needed improvements to stimulate interests in future AFPPD activities.

The survey compilation reveals an overall positive view on the seminar. The seminar is regarded as--useful particularly in terms of reactivation of AFPPD and responses to COVID-19. The respondents expressed their interest in continuing with the same issue (Ageing, particularly under the COVID-19) as the focus of AFPPD's activities. The survey indicates that the seminar was useful in terms of formulation of policies and legislations, but further discussion and more information are necessary to strengthen the governments' accountability and commitments.

The presentation of Life-Cycle Approach is viewed as useful, and the respondents are willing to disseminate the video (Note: some countries respondents are awaiting the availability of video.)

The survey also indicates that an important role for AFPPD to play is that of "platform" for knowledge sharing, especially as concerns the best practice and the facilitation of capacity-building for communication and media relations.

The written comments at the end of the survey confirmed the usefulness of the seminar as well as the expectation and hope that AFPPD would play a vital role in network-building and peer-to-peer learning among Asian parliamentarians.

The survey was framed in three parts: the first section was for logistics (Question 1-3), the second section (Question 4-14) was for the seminar, and the third section (Question 15-17) was for future activities.

The number of responses was rather limited: 13 responses were received, out of which five were from Japan; two were from the Philippines, and the rest is from 6 countries (India, South Korea, Cambodia, Kazakhstan, China, and Mongolia). The roles of these respondents are identified as:

Section 1 (Logistics):

- The length of the seminar of 3 hours (Q1) was, generally considered to be "just right," but a few participants thought it could be shortened to approximately two hours.
- All responses had relatively good internet connections (Q2), but some experienced minor interruptions.

Concerning "opportunities for interaction" (Q3), there were mixed reviews. While close to 70% of
respondents expressed satisfaction, agreeing that the seminar provided a good opportunity for
interaction among participants, a little over 30% of respondents indicated somewhat limited interactionopportunities during the seminar.

Section 2 (Seminar Contents)

- In terms of reactivating AFPPD activities (Q4), the seminar was successful--with all respondents viewing it as either "very useful" or "useful."
- However, positive responses somewhat diminished in terms of the seminar's efficacy in establishing AFPPD in view of its objectives: (1) to establish itself as an effective peer-to-peer learning and knowledge-sharing platform (Q5); (2) to catalyze global health governance, as well as future governance structures, related to population issues (Q6).
- As for the Ageing issues (Q7-10), in terms of policy and legislative formulation, the seminar was viewed as either "useful" or "very useful" (12 out of 13 responses), with positive views slightly decreasing in terms of government commitment and implementation.
- To improve the lives of the Aged (Q10): improving service quality and government measures in response to emergencies were considered the top priorities.
- The presentation of "the Life-Cycle Approach" (Q11-14) was regarded as either "useful" or "very useful" in terms of applicability to Ageing issues and to national development. Almost all respondents have committed to disseminating the video in accordance with the specific means described in the answer to Q14.


Section 3 (Future Activities)

- As for focusing AFPPD's activities (Q15): Sharing "Best Practice" information is regarded as most important, and "Facilitating the Network" as second most important.
- For this year (Q16), Ageing is regarded as the first thematic area on which to focus, followed by Youth and Gender.
- The top three more specific issues for this year's focus were: 1) Continuation of Ageing under the COVID-19 Pandemic; 2) Age Social Welfare and 3) Youth Education.
- For capacity-building activities (Q17), "Communication and Media Skills" and "Project Management Skills and Knowledge" were regarded as the top two activities on which AFPPD ought to focus.










4. For uniting and strengthening the basis for reactivating AFPPD activities:




5. For establishing AFPPD as an effective peer-to-peer learning and knowledge- sharing platform:




